## COUNTS 2-3

That on or about July 20, 2024, in Logan County, Kentucky, the above-named Defendant committed the offense of Wanton Endangerment, 1<sup>st</sup> Degree, Discharge of Firearm, while under circumstances manifesting extreme indifference to the value of human life, he wantonly engaged in conduct which created a substantial danger of death or physical injury to Kayla Stuart, and juvenile I.G., when he discharged a gun in their immediate vicinity.

Being in violation of KRS 508.060 - UOR 0132040 (Wanton Endangerment, 1st Degree, Discharge of Firearm) (F) (C)

## COUNT 4

That on or about July 20, 2024, in Logan County, Kentucky, the above-named Defendant committed the offense of Theft by Unlawful Taking or Disposition, Contents From Vehicle, Under \$500, when he knowingly took a set of keys from a Jeep Compass, belonging to Patricia Steed, said item totaling less than \$500.

Being in violation of KRS 514.030 – UOR 0241400 (Theft by Unlawful Taking or Disposition, Contents from Vehicle, Less Than \$500) (M) (B)

Against the peace and dignity of the Commonwealth-of Kentucky.
