The Grand Jury charges:

COUNT 1

ATB

That on or about July 20, 2024, in Logan County, Kentucky, the above-named Defendant committed the offense of Robbery, 1st Degree, when in the course of committing theft, and with the intent of accomplishing said theft, being armed with a handgun, he threatened the immediate use of physical force upon Bradley Grise by pointing and discharging the gun at him.

Being in violation of KRS 515.020 - UOR 0120020 (Robbery, 1st Degree) (F) (B)

COUNTS 2-3

That on or about July 20, 2024, in Logan County, Kentucky, the above-named Defendant committed the offense of Wanton Endangerment, 1st Degree, Discharge of Firearm, while under circumstances manifesting extreme indifference to the value of human life, he wantonly engaged in conduct which created a substantial danger of death or physical injury to Kayla Stuart, and juvenile I.G., when he discharged a gun in their immediate vicinity.

Being in violation of KRS 508.060 - UOR 0132040 (Wanton Endangerment, 1st Degree, Discharge of Firearm) (F) (C)

COUNT 4

That on or about July 20, 2024, in Logan County, Kentucky, the above-named Defendant committed the offense of Theft by Unlawful Taking or Disposition, Contents From Vehicle, Under \$500, when he knowingly took a set of keys from a Jeep Compass, belonging to Patricia Steed, said item totaling less than \$500.

Being in violation of KRS 514.030 - UOR 0241400 (Theft by Unlawful Taking or Disposition, Contents from Vehicle, Less Than \$500) (M) (B)

Against the peace and dignity of the Commonwealth of Kentucky.

When acting with the kind of culpability otherwise required for the commission of murder, he intentionally took a substantial step in a course of conduct planned to culminate in his commission of murder by firing a shot from a firearm at Bradley Grise, with the intent to cause his death.
